Unless otherwise defined, all capitalised terms used in this announcement shall bear the same meaning as ascribed to them in the Company's offer information statement in relation to the Rights Issue (the "Offer Information Statement") lodged with the Monetary Authority of Singapore ("MAS") on 3 July 2025. Any reference to the time of day herein shall be a reference to Singapore time.

The Board of Directors (the "Board") of COSCO SHIPPING International (Singapore) Co., Ltd. (the "Company" and, together with its subsidiaries, the "Group") refers to the Company's announcements dated 16 August 2024, 25 April 2025, 3 June 2025, 25 June 2025, 3 July 2025, 8 July 2025 and 25 July 2025 in relation to the Rights Issue.

The Board wishes to announce that 2,239,244,954 Rights Shares have been allotted and issued on 28 July 2025 pursuant to the Rights Issue. The Rights Shares will be listed and quoted on the Main Board of the SGX-ST on 30 July 2025 and trading of the Rights Shares will commence with effect from 9.00 a.m. on the same day.

Following the allotment and issuance of the Rights Shares, the number of issued Shares has increased from 2,239,244,954 Shares to 4,478,489,908 Shares.
