RENOUNCEABLE NON-UNDERWRITTEN RIGHTS ISSUE OF 2,239,244,954 NEW ORDINARY SHARES IN THE CAPITAL OF THE COMPANY (THE “RIGHTS ISSUE”) - USE OF RIGHTS ISSUE PROCEEDS

1. INTRODUCTION

The Board of Directors (the “**Board**”) of COSCO SHIPPING International (Singapore) Co., Ltd. (the “**Company**” and together with its subsidiaries, collectively the “**Group**”) refers to the Company’s announcements on 16 August 2024, 25 April 2025, 3 July 2025, 8 July 2025, 25 July 2025, 29 July 2025, 15 August 2025, 11 September 2025, 29 September 2025, 15 October 2025, 17 November 2025 and 15 December 2025 in relation to the Rights Issue.

Unless otherwise defined, all capitalised terms used in this announcement shall bear the same meaning as ascribed to them in the Company’s Offer Information Statement dated 3 July 2025.

2. USE OF PROCEEDS FROM THE RIGHTS ISSUE

After deducting the costs and expenses of approximately S\$1,000,000 incurred in connection with the Rights Issue, the Company has raised net proceeds of approximately S\$272,200,000 from the Rights Issue (the “**Net Proceeds**”).

The Board wishes to provide an update on the utilisation of the Net Proceeds as follows:
